I am directed to refer to the Department's order No.R.17011/73/2013-EP(IM-1) dated 24.10.2013 related to admission matter for the year 2013-14 intimating certain shortcomings for rectification for consideration of the case for the academic session 2014-15.

- 2. The CCIM had carried out an inspection of the institution on 07-08.02.2014 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Department.
- 3. The recommendations and visitation report of the CCIM have been carefully examined in terms of the "Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012 read with amendment Regulations of 2013, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble HFM on criteria for grant of conditional permission to ASU colleges for taking admission in the UG/PG course(s) for the academic year 2014-15 vide Department's letters No.R.11011/10/2013-EP (IM-1) dated 17.06.2014 (available at Department's website <www.indianmedicine.nic.in>) and it is found that the College is fulfilling the notified and approved criteria as follows:-

- (i) <u>Teachers:</u> For UG course: 90% eligible teachers, minimum 12 Higher Faculty (Professor/Reader) in 11 departments, at least 1 teacher in each of 14 Departments and 09 Part time teachers;
- (ii) <u>Beds in hospital:</u> Minimum 60 beds in hospital of college for UG course in case of up to 60 intake capacity;
- (iii) Minimum 120 patients per day in OPD during the year 2013;
- (iv) 40% bed occupancy for UG College in IPD during the year 2013;
- (v) Equipment and instruments: Minimum 90% of required equipment as specified under the schedule VII of MSR; and
- (vi) Fulfillment of provisions including staff requirement under relevant Education Regulations.
- 4. It has, therefore, been decided by the Central Government to grant conditional permission to the Kannada Balaga Society's Rural Ayurvedic Medical College Hospital & Research Centre, Main Double Road, Autonagar, Belgaum, Karnataka to take admissions for 40 seats in BAMS course for the academic session 2014-15 under section 13C/13A of the IMCC Act, 1970 subject to that the college shall fulfill the following conditions by 31st December, 2014 which will be verified for granting permission from the academic session 2015-16 (a copy of Assessment Sheet of CCIM is also enclosed):
  - (i) All the Minimum Standard Requirements of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012" read with amendment Regulations of 2013 by 31st December 2014 to get permission for a period not exceeding five years. Failing which, as per Sub-regulation (4) of Regulation 3 of Regulations namely the "Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012" read with amendment Regulations of 2013, "All the existing colleges, which are not able to achieve full compliance of the requirement as specified in these regulations by the 31st December, 2014, shall be denied permission from academic year 2015-16 onwards and action as envisaged under section 21 of the Act shall be initiated against all such colleges apart from rejection of their applications under sections 13A or 13C, which have been under consideration by way of conditional permissions or denials".
  - (ii) All the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled in toto.
